

SAFETY OF YOUR ASSETS

iFAST Financial Pte Ltd is licensed by the Monetary Authority of Singapore (MAS) to provide custodial services for securities. The provision of custodial services includes the safeguard and administration of client assets. In doing so, iFAST has to adhere to stringent regulatory requirements, with duties such as:

- Keeping clients' securities and monies segregated from the company's;
- Handling of clients' securities and monies received; and
- Provision of contract notes and account statements.

Your securities and monies will be kept in our client trust accounts, which are used to facilitate transactions. We have in place strict policies and procedures including risk management, internal audit and compliance, to provide a safe and reliable transaction platform for our clients.
