## How will we trade the BlackRock Managed Index Portfolios (BMIPs)?

#### For Deposits:

Where you specify 100%, we will invest 98.5% of the deposit value and 1.5% will remain in the portfolio as cash. For example:

Example 1 - 100% investment in BMIP Moderate: \$1,000 deposited invests \$985 invested into BMIP Moderate and \$15 remains in cash.

Example 2 - Investment in BMIP Moderate and BMIP Growth portfolios where 50%/50% is specified above: \$1,000 deposited invests \$492.50 into BMIP Moderate, invests \$492.50 into BMIP Growth and \$15 remains in cash.

However, please check this box if you would like 100% (not 98.5%) of the deposit value invested into your investment selections.

#### For Withdrawals:

100% of the withdrawal value will be covered by units held to ensure that the withdrawal can be completed. If more than one fund is held, please specify the percentages of units to be sold. For example:

Example 1 - Invested in BMIP Moderate portfolio only: \$1,000 withdrawal will create a sale of 100% of the required units to cover the value of the withdrawal.

Example 2 - Invested in BMIP Moderate and BMIP Growth portfolios where 50%/50% is specified above: \$1,000 withdrawal will create two sales - one sale of 50% of required units to cover \$500 of the withdrawal from BMIP Moderate and one sale of 50% of required units to cover \$500 of the withdrawal from BMIP Growth.
